LIMITATIONS

For marriages of Catholics to Eastern Non-Catholics celebrated with a sacred rite by an Eastern Non-Catholic priest, absence of form can only be used for marriages prior to: January 1, 1965 for Melkite Catholics in Egypt; January 22, 1965 for other Eastern Church Catholics, except those that follow; April 7, 1965 for Ukrainian Catholics; December 1, 1965 for Maronite Catholics; and, March 27, 1967 for Latin Catholics.
